## Certificate of Destruction

We issue a 'Certificate of Destruction' (CoD) once your documents are destroyed, this is sent to you by email.

Your 'Certificate of Destruction' and 'Waste Transfer Note' maybe required for you to demonstrate your 'Duty of Care' in processing / destroying sensitive information you hold. You should retain a copy of these documents.

Our service helps many companies with Compliance for their regulatory body and industry standards, where appropriate.

Lancashire Shredding:- is a ISO9001:2015 registered company, our processes and services are externally audited to ensure compliance to both BS EN 15713:2009, and ISO9001:2015.

Off Site, Off Site priority and Drop Off shredding are done at our secure facility under CCTV by DBS (formerly CRB) checked local staff.

## Environmental Policy

We recycle 100% of your shredded paper plus any cardboard. Once destroyed the recycled paper fibres are sent direct into local paper mills to manufacture new hygienic tissue products.

Secure Consoles & Shredding Sacks are manufactured / sourced locally.

Staff are recruited locally from our community.

When ever possible, we look to use local companies in fulfilling our obligations.
